

# International Amateur Soccer Tournament Player Release and Indemnity Agreement

By our signatures below, we confirm and represent to International Amateur Sports Inc., its co-hosts and sponsors that we are the parents or legal guardians of \_\_\_\_\_ (“**Player**”), a minor child, and we consent to Player’s participation in the International Amateur Soccer Tournament and related activities and events that are scheduled for the period from 5 to 7 December 2008 (“**Tournament**”).

We acknowledge that participation in any soccer match involves the risk of injury to the Player. Nevertheless, in consideration of the Player, Club and Team named below being allowed to participate in the Tournament, we represent, warrant, covenant and agree as follows:

1. Player is physically fit and able to participate in all matches, activities and events of the Tournament.
2. At all times relevant to the Tournament, Player is, and will be, fully covered by medical insurance that is valid in the United States for any and all injuries and/or illnesses occurring both on and off the soccer field. The following information identifies the insurance company and policy:

4. International Amateur Sports Inc., its co-hosts and sponsors, collectively or individually, do not assume any financial responsibility for any health condition of Player, any health care service and/or product provided to the Player or any property of the Player.
5. We hereby release and agree to indemnify fully and hold harmless International Amateur Sports Inc., its co-hosts and sponsors, their members, officers, directors, staff, volunteers, vendors, insurers, attorneys, employees and agents (“**Indemnitees**”) from and against any and all claims, demands, actions, causes of action, losses, damages or liability whatsoever that arise at or that are related in any way to the Tournament—including without limitation attorney’s fees, court costs and other expenses of litigation and including without limitation any claims for medical expenses, pain and suffering, physical disfigurement, mental anguish, emotional distress, loss of consortium, lost wages or any injury to property--**EVEN IF SUCH CLAIM IS BASED ON A CLAIMED NEGLIGENT ACT OF ANY OF THE INDEMNITEES.**
6. Should any health service or product be provided to Player, we consent to the attending health care provider and to the treatment, without limitation, in an emergency or otherwise.
7. We are fully responsible for all costs therefore, whether or not covered by insurance, and we will pay or cause them to be paid when service is rendered.
8. We give permission to International Amateur Sports Inc. to use the Player’s photographic likeness in all forms and media for advertising, promotion, fund raising and all other lawful purposes.
